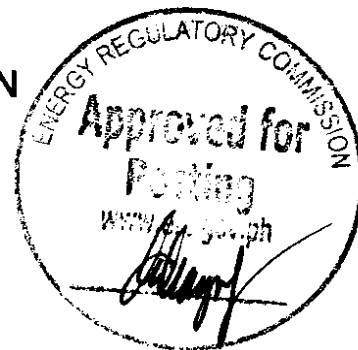

ORDER

During the January 8, 2013 hearing, only Manila Electric Company (MERALCO) and Mr. Uriel Borja appeared. The National Association of Electricity Consumers for Reforms, Inc. (NASECORE), the Philippine Chamber of Commerce and Industry (PCCI), Therma Mobile, Inc. (T-Mobile), Mr. Romeo Junia and Mr. Genaro Lualhati failed to appear despite due notice.

In the said hearing, Mr. Borja manifested that he filed on January 7, 2013 a "Motion to Resolve Explanation with Motion to Dismiss Instant Case Filed on October 1, 2012" and moved that said motion be resolved prior to his presentation of evidence.

It may be recalled that in its Order dated October 24, 2012, the Commission already treated Mr. Borja's "Explanation with Motion to Dismiss Instant Case" as his comment on the instant application.

In view thereof, the Commission maintains that Mr. Borja's motion has already been passed upon.

Accordingly, the continuation of the hearing for Mr. Borja's presentation of evidence is hereby set on **January 18, 2013 (Friday) at two o' clock in the afternoon (2:00 P.M.) at the ERC Hearing Room, 15th Floor, Pacific Center Building, San Miguel Avenue, Pasig City.**
